#### Universities doing everything they can to place students at their first-choice course



Alistair Jarvis, Chief Executive of Universities UK, said: "Universities and their admissions teams are doing everything they can to accommodate students on their first-choice course. The policy U-turn on A-levels has created significant challenges for universities caused by late movement of students between institutions. The welcome confirmation of the additional teaching grant for high costs subjects and the lifting of the cap on medicine, dentistry, veterinary and teacher training places will help to support capacity."

#### Graduate market running at 50-60% of usual hiring rates, but varies by sector



The Institute of Student Employers (ISE) are providing a weekly analysis of the graduate labour market. This week Charlie Ball writes that while the graduate labour market has suffered significant damage, particularly in the arts - which may be the worst-affected sector in the UK, things are far worse for non-graduates. Many key graduate employment sectors - in health, social care, IT, finance - have been much less affected than many other areas of the economy. Retail, hospitality, travel and accommodation employers have all taken long term hits. The level of vacancies is running at about 50-60% of normal rates. To follow the updates click here.

#### 2020 A level Trends



In her analysis of the A levels studied this year, Mary Curnock Cook writing for the Higher Education Policy Institute (HEPI) reports that Spanish has now overtaken French as the most popular Modern Foreign Language (MFL) but that MFL as a group of subjects continues to decline with only 3.3% of the total share of entries this year. Curnock Cook also identifies that "English is now a Modern Foreign Language for boys and that Physics is a foreign language for girls too" with such low uptakes. ## China making the greatest gains in Times Higher Education World Rankings announced last week



While, The US still dominates the top spots with eight out of 10 top positions, half of the US' top 20 institutions in last year's ranking have slipped this year. The UK's University of Oxford occupies the top spot for the fifth consecutive year but the success story is China. China has the first Asian university in the top 20 with Tsinghua University climbing three places to joint 20th this year. The country has also doubled its number of top 100 representatives, from three to six, in the past year, while all bar one of its top 20 institutions in last year's ranking have improved or maintained their performance. Cambridge University have stated that they will not be running the usual series of Autumn masterclasses in light of the Covid-19 pandemic. They would usually take place on Saturdays throughout the year. Looking ahead to 2021, the university will follow government guidance to make decisions about running Subject Masterclasses. They say "health and wellbeing of our visitors, staff and students remains our priority, and as such we will only run these events if we are confident that appropriate measures are in place". #### National Law Admissions Tests (LNAT) what are they and when are the deadlines?



The LNAT is used by universities to help select the right applicants for undergraduate law courses. The test doesn't test knowledge of law but assesses aptitude for the skills required to study law. It is a two-part test: multiple choice questions based on passages of text, and an essay. It is used in collaboration with other admissions processes such as UCAS application and academic qualifications. LNAT Testing begins on 1 September 2020. Oxbridge candidates need to register and book the LNAT test slot by 15<sup>th</sup> September in order to sit the test on before 15 October 2020 (UCAS deadline).

#### Half Term Virtual Law Careers Fair - Monday 26th to Friday October 30th



Aimed at undergraduates but open to school students too, the fair promises to bring top firms and law schools together in one virtual place. Students can research training contracts and internships and what is required to secure them. The day also promises live workshops and presentations from law firms, plus other events.
