# Post Qualification Admissions – a step closer?



The Policy Exchange has called for universities to be clearer about their admissions policies, stop the routine use of unconditional offers and move to a system of post-qualification admissions in a new report. The UK is one of the few countries in the world where pupils can apply to university and be offered a place before they have taken their final examinations.

Under a post-qualifications admissions system, pupils could apply to university whilst at school but no offers would be made, or places allocated, until final exam results are known. A-level exams may need to be sat earlier, or the academic year begin later to allow time to administer places after results have been released. # Demand for digital skills set to skyrocket



Research by the CBI shows that demand for digital skills is already outstripping supply and is now "set to skyrocket". Over two thirds of businesses reported unfilled digital skills vacancies. Businesses are to be encouraged to act now to inspire and support next generation by extending relationships with education providers and using apprenticeships as a route into digital roles among a raft of other measures.
